



SELECT SERIES ABOVEGROUND POOL LINER WARRANTY 25 YEAR – LIMITED WARRANTY

FINDLAY VINYL warrants to the original retail consumer purchaser, its' vinyl swimming pool liners to be of the finest workmanship. FINDLAY VINYL agrees, at its' option, to replace or repair this vinyl swimming pool liner if, during the period of the warranty it shall fail due to a separation of a welded seam within the warranty period, and the attached warranty card has been completed, signed, and returned and/or submitted electronically to the manufacturer within thirty (30) days of purchase. The Findlay Vinyl Select Series Above Ground Liner will be repaired or replaced based on the then current retail selling price and according to the following pro-rata warranty period schedule.

Select Series Above Ground Liners 25 Year Limited Pro-Rata Warranty Periods

Year 1 & 2 – N/C Year 3 to Year 5 – 25% Year 6 to Year 10 – 50% Year 11 to Year 20 – 75% Year 21 to 25 – 90%

The Findlay Vinyl Select Series Above Ground Liner Warranty relates only to liners purchased and used at a private residence. This warranty applies only to manufacturing defects and does not cover use of the product other than as a liner in a residential above ground swimming pool and specifically does not cover the following:

- Shipping, mishandling, faulty installation, improper acts of others
- Misuse, improper addition of chemicals, or poor maintenance of pool water chemical balance.
- Abrasion of pool liner print caused by automatic pool cleaners, or other mechanical devices or means
- Damage from Natural causes, fire, ice, exposure to excessive heat or cold
- Scuffing, discoloration and fading of color
- Irregularities, imperfections, or damage which may result from the removal of water from the swimming pool. (Vinyl liner swimming pools must be kept full of water at all times).
- Changes to the pool design or the use of accessories such as ladders, steps, or other entry systems which can cause damage to the liner
- Microbiological staining (such stains do not affect the ability of the vinyl to perform its intended function)
- Penetrations by organics such as nutgrass, tree roots or similar
- Pool design alteration or improper assembly
- Misuse or abuse

FINDLAY VINYL shall not be responsible for any other cost, such as labor charges, replacement water or chemicals or any additional costs from related damage that may occur.

Under no circumstances shall FINDLAY VINYL be responsible for the cost of removal or replacement of the product under warranty, nor for any other expenses or damages that might be incurred as the result of such removal or replacement.

ANY IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY SPECIFICALLY DISCLAIMED AND EXCLUDED AND ONLY THE SPECIFIC WARRANTIES HEREIN ARE MADE.
