

# FINDLAY VINYL SAFETY COVER WARRANTY 25 YEAR – LIMITED WARRANTY

FINDLAY VINYL warrants to the original retail consumer purchaser, its' Safety Cover to be of the finest workmanship. FINDLAY VINYL agrees, at its' option, to replace or repair this Safety Cover if, during the period of the warranty it shall fail due to a defect of craftsmanship, of a sewn seam or joint within the warranty period, and the attached warranty card has been completed, signed, and returned and/or submitted electronically via email or through our website, to the manufacturer within thirty (30) days of installation. The Findlay Vinyl Safety Cover will be repaired or replaced based on the then current retail selling price and according to the following pro-rata warranty period schedule.

## Safety Cover 25 Year Limited Pro-Rata Warranty Periods

Year 1 to 3 – N/C Year 4 to Year 7 – 50%

Year 8 to Year 10 – 70%

Year 11 to Year 25 - 90%

The Findlay Vinyl Safety Cover Warranty applies only to manufacturing defects and does not cover use of the product other than a winter safety pool cover and specifically does not cover the following:

- Shipping, mishandling, faulty installation, improper acts of others
- Misuse, improper installation, and exposure to chemicals other than normally balanced pool water
- Ice damage, fire damage, exposure to excessive heat or cold
- · Scuffing, discoloration and fading of color
- Microbiological staining (such as stains do not affect the ability of the vinyl to perform its intended function)
- Material breakdown to mildew, aging, or excessive and prolonged exposure to direct sunlight
- Acts of God, misuse, abuse, improper maintenance, accident, alteration of the cover, consumer negligence, fire, ice, exposure to
  excessive heat or cold
- Deterioration of the safety cover or hardware due to low water levels and excessive load on the cover (snow, water, or other excessive loads)

FINDLAY VINYL shall not be responsible for any other cost, such as labor charges, replacement water or chemicals or any additional costs from related damage that may occur.

Under no circumstances shall FINDLAY VINYL be responsible for the cost of removal or replacement of the product under warranty, nor for any other expenses or damages that might be incurred as the result of such removal or replacement.

ANY IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY SPECIFICALLY DISCLAIMED AND EXCLUDED AND ONLY THE SPECIFIC WARRANTIES HEREIN ARE MADE.

SOME STATES, PROVINCES OR TERRITORIES DO NOT ALLOW EXCLUSION OF AN IMPLIED WARRANTY, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU.
